# VIII. DEPT OF BEHAVIORAL HEALTH & DEVELOPMENTAL DISIBILITIES- JERRY FOLSOM & PAM CARTWRIGHT

Pamela Cartwright informed council on some of the services offered by Legacy Behavioral Health Services. With this month being recognized as mental health awareness month the organization wanted to updated the community about its programs. #### XIII. DISCUSSION OF PARKING VARIANCE FOR DOLLAR GENERAL

Sherry Davidson addressed council concerning Parking Variance petition presented by Tyler Graybin agent of Teremore Development for the new construction of a Dollar General in City Limits. The required parking spaces in section 4-14.6 in the Quitman Land Development Ordinance from 54 spaces to 32 spaces. The property is located on the southwest corner of East Screven St. and Second St. Voting Yes (Morgan, Neloms, Smart, DeVane). Sherry stated that the City's Planning Commission met on April 19, 2023 and voted unanimously to approve the parking variance and a public hearing was held on May 2, 2023 @ 5:00 pm. Upon motion by Donald Morgan and second by Lula Smart to approve the parking variance request from Teremore Development. Voting Yes (Morgan, Neloms, Smart) Voting No Mark DeVane. Motion passes.

Gary Christian 404 S. Walker St.- asked council if they noticed the crime rate going up in light of the two new liquor stores that has opened in the city limits. No update on this matter.

**Mattie Neloms** wanted to know if we had an update on the fair/carnival. City Manager Raphel D. Maddox stated that fall is still projected time from promoters.
